Present: Elisabeth Max-Theurer (AUT), Andrzej Salacki (POL), Daniel Karpiński (POL), Mgr. Lenka Sekanivoá (CZE), Frank Spadinger (HUN).

1. Elisabeth Max-Theurer welcomes everybody and opens the meeting.
2. The minutes of the last meeting (03.05.2018 Mariakalnok) were approved.
3. Clip my Horse:
Dieter Waldner presents ClipMyHorse Austria to the participants and informs that he has a cooperation with the Austrian NF. He would be able to offer the same terms to the participating events of CED if they book his services through the Austrian NF. Following packages are offered:
 - a. Costs: € 400,- (including vat) per day with a minimum of 3days, boarding and accommodation for 2 people, travel expenses if the location is further than 500km.
The OC has to guarantee an internet connection of minimum 10.000 Mbit/s symmetric.
 - Equipment for live stream and videoing
 - 1 camera with a cameramen and one standalone camera
 - Interviews with winners, sponsors, e.g.
 - Live video player on the web-site of the organizer
 - 10sec opener/preroll before the use of the livestream, 50% of the cost if used in ClipMyHorse
 - 45sec video in the breaks
 - b. Costs: € 250,- (including vat) per day with a minimum of 3days, boarding and accommodation for 1 person, travel expenses if the location is further than 500km.
The OC has to guarantee an internet connection of minimum 10.000 Mbit/s symmetric.
The OC is responsible for a schooled cameraman.
 - Equipment for live stream and videoing
 - 1 camera and one standalone camera
 - Interviews with winners, sponsors, e.g.
 - Live video player on the web-site of the organizer
 - 10sec opener/preroll before the use of the livestream, 50% of the cost if used in ClipMyHorse
 - 45sec video in the breaks
 - c. Costs: € 150,- (including vat) per day with a minimum of 3days, boarding and accommodation for 1 person, travel expenses if the location is further than 500km.
The OC has to guarantee an internet connection of minimum 10.000 Mbit/s symmetric.
 - Interviews with winners, sponsors, e.g.
 - Live video player on the web-site of the organizer

4. Rule Changes:

After the Pony Championships this year where a CZE and a AUT Pony was rejected because it was not on the Nominated Entry list of the NF the working group proposes to change the GR. The Nominated Entries should be stretched totally and there should be only a Definite Entry. With the Definite Entry the NF will submit a List of prequalified rider/horse combination for possible substitution. Below is the current rule extraction of the GR:

Article 116 - Entries

Entries for FEI Championships and FEI World Equestrian Games™

2.1 All Athletes invited or nominated must be entered by their NFs. All Athletes selected by their NFs, in accordance with the relevant Sport Rules and as specified in the Schedule, must be accepted by the OC. OCs may not accept any other entries.

2.2 NFs are responsible for selecting and entering qualified Horses and Athletes. This includes the fitness and capability of the Horses and the Athletes to participate in the Competitions for which they are entered.

2.32 Entries shall be made following the compulsory two (2) phases outlined below:

(i) Nominated entries

Must be made at least four (4) weeks before the Event and must include a list of the names of Athletes and Horses from which the definite entries and any substitutions will be chosen and state the number of Athletes and Horses which the NF intends to send. The number of nominated entries of Athletes and Horses must not exceed twice the number invited in the Schedule or prescribed by the Sport Rules. Once the nominated entries have been sent in, NFs may send fewer Athletes and/or Horses but never more than the number of nominated entries. NFs which are not represented after having made nominated entries and whose excuse is not acceptable to the OC shall be reported by the OC to the Secretary General for consideration of their excuse by the FEI Tribunal.

(ii)

Definite entries

Must be made at the latest four (4) days preceding the beginning of the Event. These represent the final selection of Athletes and Horses that will travel to the Event. The definite entries may not exceed the number listed and must be chosen from the list of names on the nominated entries. After the definite entries have been sent in, substitutions of Athletes and/or Horses may only be made with the express permission of the OC

5. CED Meetings: Two meetings in person will be organized, one spring and one autumn meeting. At all CED events the present members will meet for a short informal meeting.
6. Euro Dressage offers CED a web space on its home page under the condition that is permanently filled with contend, at least once a week. Andrzej Salacki suggest that each CED country nominates one media person who will be in turns be responsible for the update.
7. Andrzej Salacki presents his idea to have “Four hills tournament – ski jumping” series in the CED countries. Each country (AUT, CZE, HUN, POL) nominates one event. The three best GP results are added together. In case of equality, the best recent result determines the winner. At the last event of the series, the winner is rewarded with a special prize. Andrzej Salacki will formulate the exact rules for this series.
8. The meeting decides that Frank Spadinger will represent the CED countries at the EEF meetings.
9. The European Championships Pony will take place in Poland next year. After a short discussion what could be done to promote the idea of CED the members conclude that it would be a good start to stable the countries together.

10. The CED countries have not send a teams to the WEG 2018 because the cost where to high. In the opinion of the members of CED the following WEG's should be organized in countries where everybody can afford to participate.
11. The judges panel at the 2018 Youth Dressage Championships was not ideal and again big differences in scores happened. The youth tests should be one focus of the judges education and it should be compulsory for Youth Champion judges to attend them.

The meeting place and time of the Spring Meeting was not finalized.
